

GENERAL CONDITIONS OF SALE

HOW TO BOOK

(a) BY LETTER

Please telephone us to confirm verbally that you wish to make a booking. We will invite you to take out an option (which you will not be held to) with a time delay limit that mustn't be exceeded.

To confirm your booking please send us back the rental contract joined with a deposit of 25% of the total sum (by credit card or money order) + 20 euros for booking fees.

As soon as the withdrawal of the deposit is made we will confirm your booking by letter.

(b) BOOKINGS WITH A DEPOSIT BY TELEPHONE

Please telephone us and have your banker's card at hand to make your booking. We will together make your deposit and confirm immediately by e mail or letter your reservation.

RULES FOR YOUR STAY AND DEPOSIT

We will guarantee your place/rental but you must stay for the whole of your holiday.

The balance is due on your arrival (by credit card, cheque or cash.). For rentals a deposit of 250 euros is necessary, but it will be returned to you once the cleanliness of the rental has been verified, and that no damage has been made or that no objects are missing.

The prices extend TTC (all taxes included) with a VAT rate of 5.5% applicable from the day that it was fixed. All subsequent modifications of the rate of VAT occurring between the moment that the prices were established and the invoicing of the holiday stay will be subject to a correlative modification of the price TTC (all taxes included) that the customer must fully accept.

RENTAL CONDITIONS

The rental will be considered vacant and taken by the camp-site for rent if a delay of 24 hours has passed without written notice by letter, fax or mail that you have been delayed or after an anticipated departure. The lodging will be acquired for a new rental by the camp-site.

The "Sarl Camp de Soleil" reserves the right to modify for management purposes the number of your plot. This new rental will be equivalent and without modification of the price.

The rental includes access to the camping services (except tennis and mini golf) including the heated swimming pool.

A daily tax is required per person of more than 16 years of age from April 1st 2012 to October 31st 2012. The price is 0.50 euros per person and per day.

PETS

One small dog per rental is allowed. He will be admitted for a supplementary price on the condition that his vaccination booklet is shown. Dogs of the type pitbulls and rottweilers are banned. Dogs must be kept on a lead and should not be left alone in the lodging.

CANCELLATION

By the customer

-30 days before your arrival, the deposit and booking fees are kept by the camp-site.

+30 days before your arrival booking fees only are refunded.

All cancellations must be notified in writing.

By the "Camp du Soleil"

In case of a cancellation for reasons beyond our control the customer will obtain the double of the sum that has been deposited.

An early departure or a late arrival will not be reimbursed except in the case of illness or an accident and in this case a medical certificate will be claimed.

INSURANCE

We advise you to take out an insurance for cancellation or interruption of your holiday which will be proposed to you. (Please contact us for further information or contact directly FFCC, 78 rue de Rivoli 75004 Paris, Tel 01. 42.72.84.08

The camp-site "Camp du Soleil" declines all responsibility in case of theft. Campers should subscribe to an insurance for their tents, caravans and motor homes with personal liability.

NB. Booking fees: For lodgings from 7 nights upwards and camping during the months of July and August.
